SUBJECT AREA AND COURSE NUMBER: Music 119

COURSE TITLE: Experiences in Music

COURSE CATALOG DESCRIPTION: The student is given the opportunity to engage in a wide variety of guided musical experiences with focus on active participation. Areas of study include history, literature, technology, theory, performance, and personal music use. Field trips and individual projects are included. Formally listed as MUS 101, not open to students who have successfully completed MUS 101 (Music 119, not Music History and Appreciation and Appreciation II).

PREREQUISITES: MUS* 101 or permission by the instructor

SECTION II

- A. SCOPE: Students of Music 119 read, listen to, discuss, and participate in varied musical practices to be mutually determined by the instructor and the students. Practical immersion and performance engagement will be emphasized, as well as scholarly approaches to understanding the music to be studied.
- B. REQUIRED WORK: Students are expected to participate in all public performances of the Capital Singers.
- C. ATTENDANCE AND PARTICIPATION: Students are expected to attend all classes and to be punctual to all classes, listen critically to the music presented in class, and participate in all classroom discussions. In addition, practical engagement, such as music performance, music creation, live concert attendance and critical assessments of such concerts will be expected.
- D. METHODS OF INSTRUCTION: Methods of instruction include lecture/discussion, collaborative learning, in-class stuents presentations, use of technologies such as audio-visual, and computer internet, and live music performances.
