TRANSFER OPPORTUNITIES FOR CAPITALS TUDENTS

CCC has numerous programs for which credits are transferable to four-year institutions of higher education, both in and out of Connecticut.

Students planning to transfer to another institution are encouraged to consult with the admissions office of that institution and to seek the advice of a CCC advisor, and/or counselor.

TRANSFER TO THE CONNECTICUT STATE UNIVERSITY SYSTEM

Graduates who complete an associate degree program of a Connecticut Community College with a Grade Point Average of 2.0 or higher are guaranteed admission to the university of their choice within the Connecticut State University System (CSU).

Guaranteed admission students will have a minimum of 60 transfer credits applied toward a baccalaureate degree at the university. If a student enrolls in comparable university degree program and does not change major, the student will be required to complete no more than the specified remaining additional credits toward the baccalaureate degree requirements, in most cases. Up to 36 general education credits will be guaranteed to count toward fulfillment of the CSU general education requirements for guaranteed admission transfer students.

TRANSFER TO SAINT JOSEPH COLLEGE

Since 1991, Capital Community College (then Greater Hartford Community College) and Saint Joseph College (SJC) have agreed to facilitate the transfer process for students by outlining course equivalencies in an articulation agreement between the two institutions. CCC graduates of selected Associate of Arts and Associate in Science programs who transfer to the Women's College or coed Weekend College may be eligible to enter SJC with at least 54 and up to 61 semester hours of transfer credit. Courses in basic skills or in disciplines not generally included in liberal arts programs may not be accepted for transfer. Students graduating after 1986 from Capital Community College with a degree in nursing who are accepted to a degree program in Nursing at SJC will receive 27 credits for their Nursing program in accord with the Connecticut State Articulation Agreement for Nursing. More information is outlined in the CCC-SJC Articulation Agreement for Nursing. LICENSED PRACTICAL NURSE TO REGISTERED NURSE AND REGISTERED NURSE TO BACHELOR OF SCIENCE IN NURSING ARTICULATION



What is the GA Program at Capital?

The Guaranteed Admission program at Capital is an agreement between Capital Community College and the University of Connecticut that guarantees admission to UConn's College of Liberal Arts & Sciences, provided that certain requirements are met.

What are the Requirements for the GA Program?

Students at Capital must earn a 3.0 minimum cumulative grade point average and an associate degree in a Liberal Arts transfer program in order to qualify.

Who at Capital is eligible to participate in the GA Program?

Students who enroll at Capital with up to 15 credits are eligible to participate. Former UConn degree-seeking students are not eligible.

What Majors can you choose from at UConn?

Over 40 majors in UConn's College of Liberal Arts and Sciences are included in the GA Program. Choose from: American Studies, Anthropology, Applied Mathematical Sciences, Biological Sciences, Biophysics, Chemistry, Classics & Ancient Mediterranean Studies, Coastal Studies, Cognitive Science,

Communication Sciences, Ecology & Evolutionary Biology, Economics, Engineering Physics, English, Environmental Science, French, Geography, German, History, Pre-Individualized Major, Italian Literary & Cultural Studies, Pre-Journalism, Latin American Studies, Linguistics/Philosophy, Linguistics/Psychology, Maritime Studies, Mathematics, Mathematics/Actuarial Science, Mathematics/Statistics, Molecular & Cell Biology, Philosophy, Physics, Physiology & Neurobiology, Political Science, Psychology, Sociology, Spanish, Statistics, Urban & Community Studies, and Women's Studies.

AN AGREEMENT BETWEEN THE CONNECTICUT COMMUNITY COLLEGE SYSTEM AND THE BACHELOR OF GENERAL STUDIES PROGRAM AT THE UNIVERSITY OF CONNECTICUT

Both the Connecticut Community College System (CCCS) and The University of Connecticut's (UCONN) Bachelor of General Studies (BGS) program wish to extend educational opportunities and services to students. This agreement establishes a Cooperative Educational Pathway Program (CEP) whereby a student admitted as a CCCS student who successfully completes the Associate Degree can then move automatically into undergraduate status at UCONN as a BGS student.

Each college in CCCS will be responsible for the selection of students for the CEP program. Such students will either be newly admitted to an Associate program or already be in an Associate program at CCCS in good academic standing. Selected students will receive a letter from the BGS program at UCONN guaranteeing admission into the BGS program upon the successful completion of the Associate Degree with an overall grade point average of 2.0 or better. This letter guaranteeing admission may be given to a CEP student at the time of admission to CCCS or shortly after the student has been selected by CCCS if already admitted and attending.

For a student in the CEP program, UCONN's BGS program guarantees that he or she will begin studies at UCONN at junior level status. Course credits recognized as degree credit at CCCS will be accepted by UCONN's BGS program. Courses which ordinarily transfer Into UCONN as specific UCONN courses or as a disciplinary elective credit will transfer into the BGS program in this manner. Course credits which are ordinarily not transferable into other UCONN programs because of the subject matter involved, how credit was awarded, or the

grade will transfer into UCONN as BGS unassigned elective credits, which can only be used in the BGS program for admission. Students may enter the BGS program and pursue an individualized program of study or one of the BGS focus programs. In either case, ordinarily transferable credits can be used toward degree requirements. A CEP student can choose to enter UCONN under the UCONN catalog requirements in effect when he or she began studies at CCCS or the catalog in effect upon beginning the BGS program. Basic biographic data for UCONN computer systems as well as an official CCCS transcript will be required but the BGS application fee will be waived. If a CEP student has also attended other colleges in addition to CCCS Colleges, an official transcript from each college will be required.

Both CCCS and BGS at UCONN will share appropriate data on CEP students at the local institutional level so that both institutions can monitor each student's progress. Students in the program should be advised about this sharing of information and they agree with this provision upon their acceptance of admission into the CEP program.

CCCS students interested in being admitted or changing majors to UCONN degree programs other than BGS will be expected to follow regular application procedures and meet the appropriate admission standards of the University applicable to the desired program without a guarantee of admission to UCONN or of junior level status if admitted to UCONN.
